Chemical Group: Avermectins (Macrocyclic Lactone).

Antidote: Use symptomatic treatment.

Treatment: Poisoning followed by ingestion of the product, can be minimized by inducing vomiting inside of the first 30 minutes after the exhibition. If the toxicity progresses to severe vomiting, you should evaluate the degree of appropriate electrolyte imbalance, together with other support measures (maintenance of the blood pressure), as indicated by signs and symptoms and other clinical measurements. In severe cases, it must be Continue to observe the patient for several days, until the clinical condition is stable and normal. Because the Abamectin increases the activity of gamma aminobutyric acid in animals, it is prudent to avoid drugs that increase the activity of this substance (barbiturates, benzodiazepines, valproic acid) in patients with potential toxicity by exposures to abamectin.

Signs and Symptoms of Intoxication: Oral and inhalation: the first symptoms of intoxication that appear are the dilation of the pupils, lack of coordination and convulsions.

METHOD TO PREPARE AND IMPLEMENT THE PRODUCT

Open the container bag carefully from the top and measure the amount of product indicated on the label. Mix in the spray tank with half recommended water, then add remaining water and stir the mixture constantly.

Apply as soon adults of leaf miners or their bites appear, repeat the application at least 7 day intervals. When plants are large, dense, or heavy infestations, use higher doses.
