METHOD FOR PREPARING AND APPLYING THE PRODUCT

Carefully open the container and in a drum with water mix the amount of product according to the doses recommended, use CYMOX 10 ® with preventive fungicides to complement the healing action, shake until it is the product fully incorporated into the water, while stirring fill with the missing water until reaching the desired final volume. To obtain good results, make good crop coverage by calibrating your application equipment. It is recommended make two applications with an interval between each of 7 days. It is recommended to do the applications in the morning and without wind.

Application to foliage with water volume of 430-530 L / ha.

CONTRAINDICATIONS:

Do not apply when the crop is under stress conditions such as drought, extreme low temperatures, deficiencies nutritional or any other factor that interferes with the growth of the crop.

Do not use plant remains treated with this product as fodder.

Avoid applying when there are possibilities of rain to avoid washing the product.

PHYTO-TOXICITY:

CYMOX 10 ® is not phytotoxic if it is used in the manner specifically recommended on this label. When you do not know Potential phytotoxicity should be done a small test prior to its application to avoid undesirable effects.

INCOMPATIBILITY:

Do not mix with surfactant pesticides and / or fertilizers without previous tests that demonstrate compatibility.
