FIRST AID

In case of poisoning get medical attention immediately or call the Poison Center (ATOX) for

medical assistance 24 hours a day at 01-800-000-2869, meanwhile, it is recommended to apply the following measures of first aid:

Inhalation: bring the intoxicated to a well-ventilated area, with fresh air. If the intoxicated person does not breathe, give breathing

mouth to mouth putting a clean cloth in between. Give one breath every 4 seconds (15 breaths per minute).

Ingestion: if the intoxicant is still conscious, provide one or two glasses of water and induce vomiting by gently touching the bottom of the throat with a finger. In case the patient is unconscious do not administer anything by mouth.

Eyes: wash immediately with plenty of clean water for at least 15 minutes.

Skin: if the person is unconscious, using gloves immediately remove contaminated clothing and wash the skin with plenty water and soap. If you are aware, immediately bathe.

RECOMMENDATIONS TO THE DOCTOR

This product is a bactericide, a mixture of Systemic Aminoglycosides and Tetracyclines with Copper Sulphate. Signs and symptoms of poisoning: Upset stomach and diarrhea. Product slightly irritating on the skin. Antidote: No specific antidote is known. Use symptomatic treatment

MEASURES OF PROTECTION TO THE ENVIRONMENT

TIME OF REENTATION TO THE TREATED ZONES DO NOT ENTER THE TREATED AREA BEFORE 24 HRS METHOD FOR PREPARING AND APPLYING THE PRODUCT

Open the container carefully at the top and measure the amount of product indicated on this label, mix in the spray tank

with half the recommended water, then add the other half of water. Keep the mixture in agitation.

After using your application equipment, wash it with soap and water. Let the water circulate throughout the equipment, in order to eliminate as much as possible waste. Do not open the mouthpiece with your mouth.

CONTRAINDICATIONS

It is recommended to be used exclusively in plantations under 5 years old.

This product is not phytotoxic to the crop and in the doses indicated here, if it is applied according to the recommendations of this label.
