"FIRST AID"

Chemical Group: Triazine.

Antidote: No specific antidote is known.

Treatment: Use symptomatic treatment.

Signs and Symptoms of Poisoning: There are no known cases of poisoning or symptoms of poisoning with this product, however, the sensitive symptoms that may occur are headache, nausea, dizziness, slight irritation in eyes and skin.

MINADOX 75 PH, is a synthetic insect growth regulator, which has shown an activity against diptera, specifically leaf miners.

Its activity is manifested by interrupting the cycle of hatching of the egg, interferes with the molting process in larval stages and prevents normal pupation, causing deformed pupae that do not reach adulthood.

MINADOX 75 PH, has activity by contact and by ingestion, since the product penetrates through the leaves and is translocated to all parts of the plants. MINADOX 75 PH, can be used in integrated management programs.

METHOD FOR PREPARING THE PRODUCT

Carefully open the container from the top and add half of the required water to the spray tank, add the recommended dose of MINADOX 75 PH, continue stirring and add the remaining amount of water.

It is recommended to use a volume of water of 400-500 L / Ha.

For onions, chives and garlic, 2 applications of foliage should be done at 7-day intervals.

CONTRAINDICATIONS: It is recommended to make applications in the early hours of the morning. Do not apply in hours of intense heat or when the wind is strong (more than 15 km / hour).

PHYTO-TOXICITY: MINADOX 75 PH is not phytotoxic to the crops indicated here, if it is applied according to the recommendations of this label.

INCOMPATIBILITY: For mixtures of MINADOX 75 PH that are made with other products, it is recommended to use those that have an authorized and current registration for the crops indicated in this label, however, it is necessary to perform a physical compatibility test prior to the application.
