"FIRST AID"

In case of poisoning get medical attention immediately or call the Poison Center (ATOX) for medical assistance 24 hours a day at 01-800-000-2869, meanwhile, it is recommended to apply the following measures of first Help:

Remove the intoxicated person from the source of contamination to avoid further contact. Get immediate medical attention and show him the label. Keep the patient warm and at rest.

If the product was inhaled, place the person in a cool, well-ventilated place away from the contamination area. If the person does not breathe, start artificial respiration immediately. Do not apply mouth-to-mouth breathing when the person has swallowed product or have contaminated the face.

If there has been any splashing in the eyes, wash them for at least 10 minutes under running water.

If there was spillage on the skin, wash it thoroughly with soap and water and remove the contaminated clothing from the intoxicated person.

If you have swallowed the product and the person is conscious, induce vomiting immediately by inserting a finger into the throat or administering warm or salty water.

If the person is unconscious, make sure they can breathe without difficulty, do not induce vomiting and do not try to introduce absolutely nothing in the mouth

"RECOMMENDATIONS TO THE DOCTOR"

Chemical Group: Amitraz belongs to the chemical group of amidines.

Antidote: No specific antidote is known.

Treatment: In case of ingestion of the product, the stomach should be washed and the patient kept under observation for 24 hours. Do not induce vomiting. Special attention should be paid to the respiratory system. In case of severe depression, they will be necessary measures of general support and artificial respiration. If absorbed, the probable symptoms can be similar to those of depression of the central nervous system. Provide symptomatic treatment.

Signs and Symptoms of Intoxication: Headache, vomiting, intestinal spasms and diarrhea.

"MEASURES FOR PROTECTION TO THE ENVIRONMENT"

METHOD FOR PREPARING AND APPLYING THE PRODUCT

MITOFF® can be applied with any terrestrial application equipment. Fill the application tank up to ¾ of its capacity and add the dose to apply the product.

Triple wash the container and add the wash water to the spray tank

CONTRAINDICATIONS:

Do not apply with strong winds or temperatures above 35 °C.

MITOFF® is not phytotoxic if it is used in the manner specifically recommended on this label.

INCOMPATIBILITY:

MITOFF® is compatible with most of the phytosanitary products registered in the crop authorized on this label, without However, it is recommended to carry out a small compatibility test before mixing it with other products.

Do not mix with highly alkaline products.
