METHOD FOR PREPARING AND APPLYING THE PRODUCT

Carefully open the bag using your mask.

Calibrate the application equipment, in a separate container place a small amount of water, add the product at the recommended dose on this label and shake, then empty this premix to the equipment tank and add all the water calculated in the calibration.

It is recommended to keep in agitation.

#### CONTRAINDICATIONS

Do not apply with strong winds or temperatures above 35° C.
